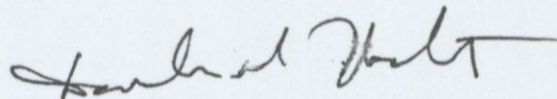

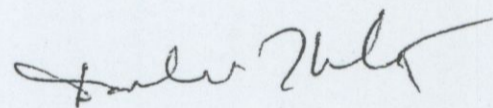
Sub: Review Committee of House Allotment Rules

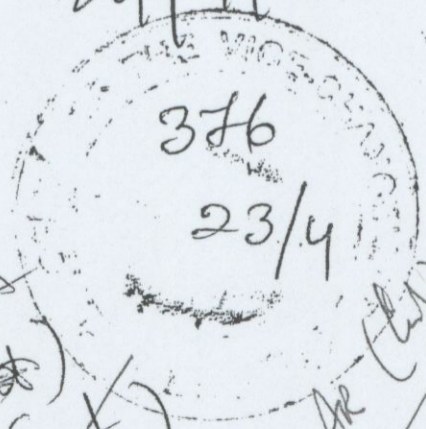

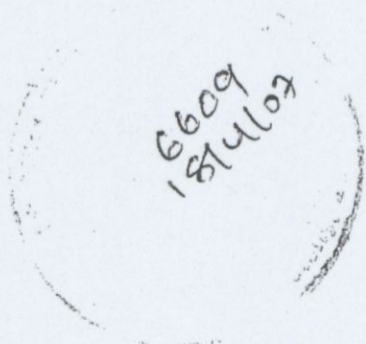
