

(v) Appointment of Shri J.Lhungdim, to the post of Finance Officer on Standard Deputation term.

Shri J.Lhungdim, Director, Govt. of India, Ministry of Defence(Finance), New Delhi is one of the candidate who applied for the post of Finance Officer against the Advertisement No.F.1-4/Estt-II(B)/2000-168 dated 29.7.2000. Shri Lhungdim submitted his application for the post of Finance Officer, NEHU through the Deputy Financial Adviser,(Estt), Govt. of India, Ministry of Defence, New Delhi. As the interview for the post of Finance Officer could not be conducted as the whereabouts of the Visitor's nominee is not known, a committee was set up by Vice-Chancellor to consider the two candidates for deputation as Finance Officer in view of Shri L. Nampui's term which will be over by April, 2001. The Vice-Chancellor approved the recommendation of the Committee in appointing Shri J. Lhungdim on standard deputation terms for a period of 3 years w.e.f. his joining. Shri J. Lhungdim has communicated his acceptance of the offer of appointment of Finance Officer on standard deputation vide his letter dated 22.3.2001(ANNEXURE-I), and requested to join the post after the appointment Committee of Cabinet's approval is obtained by 30.4.2001. The amended provision of Statute-5 in connection with the appointment of Finance Officer is placed at ANNEXURE-II.

The matter is placed before the Executive Council for ratification.

(1) The Finance Officer shall be appointed by the Executive Council on the recommendation of the Selection Committee constituted for the purpose of on deputation from an organised Accounts Service. The appointment of the Finance Officer shall initially be for a period of three years which may be extended by one more year. He shall be a whole time salaried officer of the University.

(1) The Finance Officer shall be appointed by the Executive Council on the recommendation of the Selection Committee constituted for the purpose or on deputation from an organised Accounts Service. The appointment of the Finance Officer shall be for a period of five years and in the case of deputation on usual Government of India's deputation terms. He shall be a whole time salaried Officer of the University.

(2) Provided that a Finance Officer shall retire on attaining the age of sixty years.

2. Provided that the Finance Officer shall retire from Office on attaining the age of 62 years.

Provided further that the Finance Officer shall notwithstanding his attaining the age of sixty years continue in office until his successor is appointed and enters upon his office or until the expiry of a period of one year whichever is earlier.
