(iii) Re-employment of Prof.J.C.Binwal.

Prof.J.C.Binwal, Department of Library and Information Science will retire on superannuation on December 31st,2001 as his date of birth is 19.12.1939. The Head of Department forwarded the application of Prof.Binwal stating that the department meeting held on 13.3.2001 unanimously recommended the continuation of the services of Prof.J.C. Binwal for three years after his retirement on 31.12.2001.

In this connection, Prof Binwal has served the University continuously for a period of over 23 years and joined as a Librarian with effect from 5.7.1978, thereafter as a Professor with effect from 11.7.1991. He has also fulfilled the eligibility and procedure laid down in the amended Rule RU-2 of the Re-employment. Therefore he is eligible for re-employment with effect from 1.1.2002.
