- (v) Deputation term in respect of Dr. Sapu Changkija, Scientific Officer, RSIC, NEHU.

Dr. Sapu Changkija, Scientific Officer, RSIC, Shillong on completion of 4 years deputation period at G.B. Pant Institute, of Himalayan environment and Development w.e.f. 13.12.93 to 10.11.97 resumed his duties in NEHU on 19.11.97. Thereafter, Dr. Changkija applied for the post of Reader in Nagaland University which followed by an appointment order on deputation from the Registrar, Nagaland University.

The case was taken up in the 97th E.C. for consideration of "Cooling off" period in between two deputation term together with Dr. Changkija's services for placement at Nagaland University on deputation terms. However, the 97th E.C. in its resolution No. 97:98:6:3(v) held on 14.7.98 (Annexure-1) considered only the release of Dr. Changkija but on lien instead of deputation for a period of 1 (one) year.

To enable Dr. Changkija to join Nagaland University as Reader, the Vice-Chancellor released him on standard deputation term for a period of 1 year w.e.f. 13.8.98 subject to further ratification of the term 'lien' to 'deputation' (Annexure-II).

The matter is placed before the E.C. for ratification.
