- (ii)- Change of name in respect of Dr.Oinam B.Singh ,
Lecturer Department of Philosophy.

Dr.Oinam B.Singh Lecturer in the Department of Philosophy, submitted on affidavit and a photocopy of the Public Notice published in Shillong Times dt.8.6.2002 stating that he has changed his name Oinam Bhagat Singh to Bhagat Oinam Singh (Anex-I & II)

In terms of G.O.I provision for change of name, the Government servant besides executing a deed and publishing in a prominent local Newspaper has to get his name published in the Gazette of India.However,there is a precedent case of change of name in respect of Dr.K.Deb Barma ,Reader,in Political Science,where the University exempted the University employes from Publication of change of name in the Gazettee of India,since the employes are not serving under Central Government of India but under an autonomous body.Accordingly, the council vide resolution No.EC:89:96:6:7:(i) held on March 8,1996, approved the change of name of Sh.P.K.Debbarma to Khakchang Debbarma.

Under the circumstances, the request of Dr.Oinam Bhagat Singh,Lecturer,deptt. of Philosophy,could be considered for change of name to Dr.Bhagat Oinam Singh on the similar line as in the case of Dr.K.Debbarma,where the council has exempted the employees of NEHU from publication of the change of name in the Gazettee of India.

The matter is placed before the council for decision.
