

In the absence of a final decision to start a NEHU campus at Tura and another one in the Jaintia Hills District of Meghalaya, the Academic Council took the following decisions in respect of the NEHU employees of the erstwhile Kohima and SASRD campuses with effect from January, 1996.

IV. The Non-Teaching employees seventynine
(will be done by Admn.)

The Council anxiously considered the impending repatriation of NEHU employees from its erstwhile Nagaland campus and unanimously RESOLVED to remind the U.G.C and the Human Resource Development Ministry, as per earlier agreement, to immediately release the funds for the payment of salaries and ~~ax~~cillary expenditure as well as the creation of the departments of Geology, Commerce, Linguistics, the College of Agriculture and The School of Agricultural Sciences and Rural Development(SASRD) on its other campuses in order to make the services of the repatriated personnel effective. The U.G.C., the Council felt strongly felt strongly, must expedite the whole process on a top priority basis, to save NEHU fruther from embarrassment.

The Council RESOLVED to press upon the U.G.C and the Human Resource Development Ministry the dire urgency of the need to set up campuses at Tura and in the Jaintia Hills.

Contd/.../-

The Council further RESOLVED that in the event of any other new University being created within the jurisdiction of NEHU provisions for the division of assets and liabilities should be made well in advance so as not to affect the interests of NEHU adversely.

The Council further, accepted the apology tendered by a teacher with regrets for not having followed the normal protocol of making a representation and expressed its concern about such matters.

- (iv) Introduction of a course on Environment as a Compulsory subject at Under-Graduate and Post-Graduate levels.

No: AC: 51: 95: 5: 6: (iv): The Council considered the question of starting a course on Environment awareness at both the Under-Graduate and Post Graduate level and RESOLVED that as regards the Under-Graduate level a Compulsory paper on Environmental Awareness may be introduced in lieu of the General Foundation Course. As regards the Post Graduate level non credit compulsory course may be introduced which would be served at three nodes i.e. Mayurbhanj, Bijni and Permanent Campus. A Committee consisting of the following members will design the course.
