(4) Grant of Sabbatical Leave for a period of 1 year w.e.f. 2.3.2000 to 1.3.2001, in respect of Prof. R.L. Walli, department of Pol. Science, NEHU.

Prof. R.L. Walli, department of Political Science, NEHU, has submitted an application for the grant of sabbatical Leave for 1 (one) year w.e.f. 1.3.2000 to 28.2.2001 for academic purpose. The request for the said leave has been forwarded by the Head of the Department and since approved by the School Board of Social Sciences (Annexure - I). Prof Walli was earlier sanctioned sabbatical leave for 1 (one) year w.e.f. 1.3.93 to 28.2.94.

Considering that Prof. Walli would complete the required 6 years service after expiry of the sanctioned sabbatical leave on 1.3.2000 under provision of Clause 11(ii) of Ordinance OE-6, and that he would retire on 31.12.2005, the Vice-Chancellor, NEHU, has approved the grant of the 2nd spell of sabbatical leave w.e.f. 2.3.2000 subject to execution of the required Bond under Clause 11(iii) of OE-6 and renders 3 years of service after expiry of the sanctioned sabbatical leave w.e.f. 2.3.2000 to 1.3.2001.
