

( i.i) Relaxation of Qualifications for appointment to the post of Lecturer in Khasi, Garo and Mizo.

The Executive Council in its 97<sup>th</sup> meeting had constituted a Committee consisting of the following members to draft an Ordinance for Relaxation of Qualifications for appointment to the post of Lecturer in Khasi, Garo and Mizo.

The Committee met on 3<sup>rd</sup> September, 1998 and decided to recommend that since the existing qualifications for University teachers are laid down in Regulation RE-4. The relevant Clause as per Annexure only be amended.

**(i) Amendment of Clause (3) of Statute 3 on the Pay and Allowances of the Pro-Vice-Chancellor.**
