vii) Proposal for enhancement of Hostel fees etc,

The proposal for enhancement of Hostel fees was discussed in the 57th meeting of the Academic Council wherein, the Council considered and approved the enhanced rates of Hostel rent from 17/- to Rs.50/-, Hostel caution deposit from Rs.200/- to Rs.500/- and Hostel application form fee of Rs.2/- copy. The Council further resolved that the enhancement of the Student's Association fund fee from Rs.10/- to Rs.20/-, Student Aid fund fee from Rs.20/- to Rs.40/- and a new Recreation fund fee for Rs.200/- per annum be discussed by the DSW with the Students and the Chairman is authorised to take a decision on the matter. All the above fees will be applicable only to the Students enrolling from the 1998 academic session only. The DSW as per resolution of the Academic Council has adopted the enhanced rates only for Hostel rent, Hostel caution deposit and Hostel application form fee, whereas, with regards to Recreation fee the DSW discussed the matter with the NEHUSU and other students representatives and it was informed that this fee be at present kept in abeyance and should not be introduced. However, as authorised by the Academic Council in its 57th meeting, the Chairman has approved the enhanced rates of Hostel fees only.

The matter is placed before the Council for ratification.
