

- (v) Request for extension of EOL in respect of Dr. Elizabeth Laitflang, Reader, department of Pol. Science.

Dr. E. Laitflang, department of Pol. Science was granted EOL for 1 year w.e.f. 1.7.99 to 30.6.2000 vide EC Resolution No. EC:103:99:6:3:(vi) held on 25.6.99 to enable her to take up an assignment at M/s Etrily, London. Further, the EC No.104:99:6:6:(ii) held on 26.10.99, considered the remittance of Leave Salary and Pension contribution in respect of Dr. E. Laitflang, Reader in Pol. Science, during the period of lien and resolved that she may be asked to remit the pension contribution.

Dr. Laitflang has now requested for an extension of another 2 years w.e.f. 1.7.2000 to 30.6.2002 (Annexure-I).

The maximum period of EOL as per Clause 8 (iii) (b) of the Ordinance OE-6 is 2 years.

The Vice-Chancellor has considered and granted the extension for another 1 year w.e.f. 1.7.2000 to 30.6.2001.

The matter is therefore placed before the EC for ratification of the action taken by the V.C. and the same condition may also be considered that she should remit the pension contribution for the second year of her EOL.
