

Appointment of Head, Department of Khasi

Prof. B. War was appointed as Head of the Department of Khasi for a period of three years w.e.f 19th April, 2006 vice Prof. M.B. Jyrwa, since relieved from the Headship on her request. Now, a letter has been received from Prof. B. War, the present Head of the Department expressing her inability to continue as Head of the Department on health ground (**vide Annexure-A**). The criteria for appointment of Head of the Department has been laid down under Clause-7 of the Statute of the NEHU Act, 1973. As per sub-clause-4 under Clause-7 of the Statute, it has been provided that the Head of the Department may resign his office at any time during his tenure of office. As such, the Council may like to consider and accept the resignation of Prof. B. War.

As per the provision laid down under Clause-7(1) of the Statute, "the departments which have more than one Professor, Head of the Department shall be appointed by the Executive Council on the recommendation of the Vice Chancellor from among the Professors. It may be noted that the Department of Khasi has three existing Professors, namely, Prof. B. War, Prof. M.B. Jyrwa and Prof. S. Dkhar. Dr S. Dkhar was appointed as Professor in the Department of Khasi w.e.f 20.12.06 and has been confirmed against the post of Professor. From the existing Professors in the Department, the Council may like to note that Prof. M.B. Jyrwa was appointed as Head of the Department for a period of three years w.e.f 16.1.06. However, due to illness, she could not continue as Head of the Department. She has served as Head of the Department for the period from 16.1.06-25.4.06. As a fall out of this, Prof. B. War was appointed as Head of the Department w.e.f 26.4.06.

Under the above circumstances, the Vice Chancellor has recommended Prof. S. Dkhar for appointment as Head of the Department of Khasi.

The matter is placed before the Council for consideration.
