Dr. R.C. Laloo, Reader, Deptt. of Botany, has been reinstated w.e.f. 4.1.02, approved by the Executive Council at its 111th meeting adopted on Dec.11, 2001. Dr. Laloo in his letter dtd.21.1.02, stated that the Govt. of Meghalaya offered him the post of Dy.Chairman, State Planning Board, on an honorary basis and the post where his presence is needed only twice or thrice a year whenever there is a meeting of the Board .
