

(x) Joining of Dr R.C.Laloo in the Department of Botany,
w.e.f 15.5.98.

Dr R.C.Laloo, Reader, Department of Botany has submitted his withdrawal of resignation, for which the matter was placed to the Executive Council in its last meeting held on 24th March, 1998 and the Executive Council vide resolution No.EC:96:98:6:2:(x) resolved that the same is regretted as his resignation has already been accepted.

In the meantime, Dr R.C.Laloo has filed a case in the Court and the University had received the judgement dated 4.5.98 from the Hon'ble High Court and the order of the University dated 2.4.98 at Annexure-I is suspended until further order of the court. It was also further stated in the judgement that it has further made clear that pendency of this case shall not stand on the way of the University/respondent to take back the writ petitioner into service.

The matter was examined on the judgement of the Court and the Vice Chancellor has approved that Dr R.C.Laloo to join his duty and he joined the University on 15.5.98 for which his charge report has been received and countersigned by the Head of the Department concerned. The letter dated ~~14.5.98~~ issued to Dr R.C.Laloo to join his duty is subjected to further orders that the Hon'ble High Court may please to pass in the writ petition CR No.44(SH) of 1998.

The judgement of the Hon'ble High Court will be tabled by the Chair.

The matter is placed before the Executive Council for ratification. It may also be mentioned that the University is replying to the writ petition received from the petitioner and on disposal of the case, the same will be reported to the Executive Council.
