Dear Dr. Patton,

Please refer to NEHU's letter No. Conf/15-1/Stat/87-3803, dated November 22, 1995 regarding amendment to clause-4 of the Statute 2A of North-Eastern Hill University Act, 1973.

While examining the amendment to clause 4 of Statute 2(A) under reference, it was felt that the Statute on pay and service conditions of Vice-Chancellors need amendment as and when new pay scales of the Vice-Chancellors are notified by Government/UGC. Therefore, it may be more appropriate if the Statute on pay scale and service condition of Vice-Chancellor is as under:

Vice-Chancellor shall be paid a salary and other allowances as approved by Government of India/UGC from time to time. Terms and conditions of the service of VC shall be in accordance with the Model Ordinance prepared by UGC and amended thereto from time to time in this behalf.

Moreover, if the University wish to put any specific condition or provide some facility for Vice-Chancellor in addition to what approved by Government/UGC, it may go for a suitable clause in the Statute for the purpose.
