

- (x) Recommendation of names by the Executive Council for appointment of Chancellor.

The Executive Council in its meeting held on 2.3.97 and 10.12.97 vide Resolutions No:EC:94:97:6:2:6(i) and No:EC:95:97:6:2(xi) recommended three names namely, (1) Prof D D Bhawalkar (2) Prof A L Nagar and (3) Prof M V Pylee for consideration of the Visitor for appointment as Chancellor under the provisions of Statute 1 of the University. Accordingly, the panel of names as recommended by the Council was submitted to the Ministry of Human and Resource Development alongwith their bio-data for consideration of the Visitor.
