

viii) Extension of appointment of Ms.S.A. Lyngdoh as Lecturer on contract.

The Executive Council vide resolution No. EC:104:99:3:(ix) held on 26.10.99, considered the appointment of Ms.S.A.Lyngdoh as Lecturer on contract in the Department of Linguistics w.e.f. August 2,1999 for a period of six months. The term of appointment on contract basis expired on January 31,2000. The Head of the Department vide her letter dated 15.2.2000(ANNEXURE-I) has requested for consideration of re-appointment of Ms. S.A. Lyngdoh, since her services are crucial in the running of the Department for lack of staff.

Ms. S.A.Lyngdoh was appointed as Lecturer in the Department of Linguistics for a period of 6(six) months w.e.f. 2.8.1999, under Ordinance RE-3. As per para-3 of RE-3, which stated :-

"The appointment shall initially be for a period of two years during which period the appointee shall have opportunity to seek employment against a regular post in the University whereafter he may look for an appointment elsewhere.".

In view of scarcity of staff in the Department, the Vice-Chancellor, considered the request made by the Head of Department & Ms. S.A.Lyngdoh is considered for re-appointment for another period of 6(six) months w.e.f. 2.3.2000 as prayed for by the Head of the Department.

The matter is placed to the Council for ratification.
