

(iii) Grant of lien to Dr.K.C.Baral, Reader, Department of English, Shillong.

Dr. K.C.Baral, vide his application dated 28.7.1999 informed that consequent upon his selection as Professor in English at CIEFL, RC, Shillong, requested for grant of lien as admissible for a period of two years, and to release him at the earliest to join the new post. The Head of Department, while forwarding the application stated that the department, has no objection to Dr.Baral being released from the present position to join as Professor CIEFL.

The post applied by Dr.Baral, is a higher post and the application was duly forwarded by NEHU. Further, he is a confirmed teacher of NEHU and has served the University continuously for more than 20 years w.e.f. 8.2.1980. Under consideration to the above, the Vice-Chancellor, approved the grant of lien for a period of two years and Dr. Baral was released w.e.f. 11.8.1999 A.N.

On expiry of the two years lien period on 10.8.2001 AN, Dr.K.C.Baral vide his application dt.10.7.2001, (Annexure-I) through the Head of Department, English, requested for extension of lien for another period of one year, w.e.f. 11.8.2001 to 11.8.2002, on the ground that CIEFL is at a crucial stage and his continuance is very important for the Institute.

Considering the above, the Vice-Chancellor approved the extension of lien for another period of one year w.e.f. 11.8.2001.

The matter is reported to the Council for ratification of the grant of lien to Dr.K.C.Baral for the period w.e.f. 11.8.1999 to 10.8.2001 AN and the extension for one year from 11.8.2001 to 10.8.2002.
