

- (ix) Extension of the term of appointment as University Legal Adviser for a further period of three years with effect from 28.7.1996.

The Three-year contract term of Appointment of Mr. Sunil Ranjan Sen, Advocate, Gauhati High Court (Shillong Bench), as the Legal Adviser of the University, effective from 28.7.93(F/N) will expire on 27.7.96(A/N). His appointment is approved by the E.C. at the 79th Meeting held on 20.7.93. The terms and Conditions of the contract appointment are spelt out in the order dt. 15.9.93 at Annexure 'A'. This regulates the payment of a monthly retainership fee, besides other fees for drafting, conducting of court cases etc. The term of the contract is terminable by either party on giving one month's notice.

Considering his valuable service to the University in respect of all legal matters especially Court cases involving the University and other judicial matters requiring his advise and comments. Over and above the arbitration proceeding in the matter of dispute between the University and M/s. K.B. Tiwari Electrical Co. PVT.LTD. extension of his service on the same terms & conditions for further period of three years w.e.f. 28.7.96(F/N) is deemed necessary. Shri S.R. Sen, advocate has accepted the offer made in this regard vide his letter at 2.7.96 at Annexure B.

The matter is placed before the E.C. for consideration and approval.
