The Council, however, decided to forward these representations to the Visitor with the comments of the University.

In this regard, the representation of Prof. S.N. Rai, of the Computer Centre was also considered and his allegation that, in retaining the services of the members of faculty of the erstwhile ISOSB, the University violated the University's laws and rules, was found baseless. It was also **RESOLVED** to ask Prof. S.N. Rai to explain why he marked copies of his representation to the Visitor and authorities outside the University without awaiting the EC's response.
