

- (ii) Appointment of Visiting fellow in the Centre for Cultural and Creative Studies.

There are (2) post of Readers and 1 (one) post of Lecturer lying vacant in the Centre for Cultural & Creative Studies for quite some time. Efforts were also made by the University to fill up these posts through advertisement, but due to lack of qualified candidates, the said post could not be filled till date.


