Prof.M.M.Agrawal, Professor, Philosophy Department retired from the University service on 30.6.96 and was re-employed as Visiting Fellow for a period of one year with effect from 12.8.96 vide Executive Council resolution No:EC:90:96:6:2(i) held on 18.7.96.
