

Item No. 3 RATIFICATION OF ACTION TAKEN BY THE VICE-CHANCELLOR:

- (i) Technical resignation of Dr.A.K.Gupta from the post of Lecturer, PUC, Aizawl.

Dr.Akhilesh Kr.Gupta joined the Pachhunga University College Aizawl on 4.8.90 as Lecturer in Chemistry Department. He applied for the post of Lecturer in Chemistry NERIST, Itanagar and his application was forwarded through proper channel. On his selection to the post he was released on lien for a period of one year w.e.f.20.10.93 to enable him to take up the new assignment. This was approved vide Executive Council resolution No.80:93:03:(xiv) dated 6.12.93 followed by an order No.15-95/Estt.II/90-153 dated 19.10.93.

On expiry of the lien he had applied for extension for a period of one year but he was not granted. However he was permanently absorbed in the said organisation and he was directed to tender his resignation from the post of Lecturer, Department of Chemistry, PUC, w.e.f. 21.10.93 and the same was received by the office vide his letter dated 29.8.96. The case was examined and his technical resignation was accepted by Vice-Chancellor.
