- (iii) Enhancement of Application fees for various faculty positions and Group-A posts.

On the above subject, it may be stated that the University is presently charging a sum of Rs. 50/- only as application fees (Rs.25/- in case of SC/ST candidates) and Rs.10/- as the cost of the prescribed printed application forms which is issued by the Head-quarter as and when there is an advertisement.

In the context of the aforesaid application forms it may be stated that initially the Pro-Vice-Chancellor, NEHU, Mizoram Campus had taken 50 Nos. of the above application forms for use by the Mizoram Campus Office so as to meet the requirements there. Subsequently, the Deputy Registrar (Mizoram Campus) further requisitioned 200/- copies of the said forms for the said purpose.

In this connection, it may be stated that the University have to get printed more number of such forms so as to meet the requirements. Herein, it may be noted that the University is not only incurring expenditure on printing of such forms but also a huge expenditure on account of advertisements of various faculty positions and Group-A posts as the advertisement is being made in four National papers to cover the Northern, Southern, Eastern and Western region as per Clause 2(1) of OE-4 of the Ordinance.

In the above view, it is felt that the aforesaid application fees of Rs.50/- for General candidates and Rs.25/- for SC/ST candidates may be enhanced to Rs.100/- and Rs.50/- respectively and the cost of application forms be raised to Rs.20/- (Rupees twenty) only from the present rate of Rs.10/- (Rupees ten).

The matter is placed before the Council for consideration and necessary approval.

- (i) By - Laws of Records Management Committee of the Records Department.
