

(xi) Appointment of a separate Legal Adviser  
for Mizoram Campus, Aizawl -

A proposal for appointment of a Legal Adviser exclusively for Mizoram Campus has been received vide Annexure - I. Considering the exorbitant amount of fees chargeable by Sr. Advocates in Mizoram, having a separate Legal Adviser is a better proposition. Provided, retainership fee and other fees for drafting, appearance are quite reasonable. There are approximately four number of cases filed at the High Court, Aizawl Bench which are but a few comparing to the number of cases pertaining to Mizoram Campus itself, filed at the Principal Seat at Guwahati. Other matters having legal tangle/implication requiring legal advice or comments are also being attended to by the University Legal Adviser at Shillong. This includes such matters relating to the Mizoram Campus also. The proposed setting up of a separate University for Mizoram may also be taken into consideration in this regard.

The matter is placed before the E.C. for its consideration and approval.
