

- v) Appointment of Prof.A.L.Verma as Director ,NERIST on standard deputation terms and condition and his release on lien.

Prof. Verma, vide his letter dt.27.10.2000, at Annexure-I stated that he has been offered the post of Director NERIST, a tenure post and that he is willing to join that post by Nov.1st. 2000 and would like to be released from NBHU on deputation under usual terms and condition. He further added that if there is problem in releasing on deputation, he may be released on lien w.e.f. 1.11.2000. In this connection and in absence of formal request from NERIST for his service on deputation. The Vice-Chancellor approved the grant of lien, subject to ratification of the B.C. and Prof.Verma was released on two years lien w.e.f. 30^(AN) Oct.2000 to enable him to take up a new assignment. However, a letter dt.14.11.2000 at Annexure-II & III has been received from NERIST, requesting to convert the lien to standard deputation terms and condition as the appointment as Director on deputation has been considered and approved by the Chairman Board of Management, NERIST, and has agreed to pay all the foreign contributions admissible under the rules as LS, PC, Transfer/Joining TA, and others.

In view of above, ^{and} letter received from NERIST, the two years lien earlier granted to Prof.A.L.Verma may perhaps be cancelled and his services be placed on deputation for a period of two years w.e.f. 1.11.2000 ^(FN) under standard deputation terms as amended from time to time.

The matter is placed before the Council for consideration.
