

(v) Appointment of Headship in the Department of English.

The Executive Council in its resolution No:EC:97:98:3:(i) approved the appointment of Prof.T.Ao as Head of the Department English, for three years with effect from 13.5.98. The term of Headship will expire on 12.5.2001. The Executive Council vide resolution No:EC:105:99:3:(i) resolved that all appointments of Head of Department/Deans be placed before the Executive Council at least three months ahead of the expiry of the term.

In terms of the amended Cl(3) of Statute-7 approved Vide Resolution No:EC:97:98:5:1:(V): on the term of Office of the Head of Department, a teacher ceases to be Head of Department on attaining the age of 60 years. In this connection the Department of English, Shillong, in order of seniority has at present the following Professors as:-

Prof.R.P.Sharma joined as Professor with effect from 19.8.96 and in order of seniority is eligible for appointment as next Head, and will attain the age of 60Yrs on 8.11.2003. In terms of the amended Cl.(3) of Statute-7, he would be serving as Head for a period of two years-Four months- Seven days.
