

- (ii) Technical Resignation from the post of Sr. Lecturer Horticulture in respect of Dr. D. Sanyal with effect from 31.8.1998.

Dr. D. Sanyal was appointed as lecturer in Horticulture, SASRD, Medziphema on 26.8.89 (AN) and was placed in the Sr. Scale with effect from 26.8.94. Consequent upon the establishment of Nagaland University he was placed on deputation to Nagaland University and reverted back to NEHU (HQ) on 1.7.97. Meanwhile he was selected for appointment to the post of Reader in the department of Forestry NEHU, Mizoram Campus and also in the post of Reader in Visva Bharati University West Bengal. The application for the post of Reader in Visva Bharati had been forwarded by NEHU Head Quarter. Dr. D. Sanyal having expressed his willingness to join at Visva Bharati had requested lien for a period of one year, which was granted subject to ratification of the Executive Council (ratified by EC.No.94:97:3:(V) dt.23.9.97). Dr. Sanyal was released on lien for 1 (One) year with effect from 30.8.97 (AN) to take up the assignment as Reader in Visva Bharati University.

The Registrar Visva Bharati University had issued an Order for confirming the services of Dr. D. Sanyal with effect from 31.8.98 to the post of Reader in Horticulture vide Annexure 'A' and Dr. Sanyal has also submitted his technical resignation from the post of Sr. lecturer in Horticulture after expiry of his lien period with effect from 31.8.98 (FN). The pension Contribution/Leave Salary Contribution for the period of his lien has been submitted by him and there is no outstanding dues against Dr. Sanyal.

In view of the above the Vice-Chancellor, NEHU has accepted the technical Resignation of Dr. D. Sanyal with effect from 31.8.98 (FN).

The matter is placed before the Council for ratification.
