

(ii) Appointment of University Engineer -

The Executive Council in its 100th meeting held on 16.3.99 has approved the extension of Shri B. Kharmalki, Adviser (Construction & Maintenance) for a further period of three months w.e.f. 1.1.99 upto 31.3.99 and resolved that no further extension be given. This may kindly be seen (at annexure - I)

In view of the E.C's decision at annexure I the University made a request to the Secretary, P.W.D. (R&B), Government of Meghalaya to lend the services of Shri H. Syiem, Addl. Chief Engineer either on deputation for an initial period of one year on full-time basis or as a part-time assignment till the appointment of a regular Engineer.

In reply, the Secretary, PWD(R&B), Govt. of Meghalaya notified that Shri H. Syiem, Additional Chief Engineer's services has been partially placed at the disposal of NEHU for appointment as a part-time assignment as University Engineer in addition to his own duties without detriment to his normal function - annexure II.

The Vice-Chancellor, NEHU has, therefore, appointed Shri H. Syiem, Addl. Chief Engineer, PWD(R&B), Government of Meghalaya as University Engineer on part-time assignment with effect from 31.3.99 (AN) (Annexure III) and Shri H. Syiem has taken over the charge of the University Engineer as part-time assignment with effect from 31.3.99 (AN).

The V.C., NEHU has approved the amount of Rs. 4000/- (Rupees four thousand) only per month as a consolidated honorarium for holding the part-time assignment in addition to Rs. 1500/- p.m. sanctioned for POL expenses for utilising his allotted Government of Meghalaya vehicle for official NEHU work.

The matter is placed before the Council for ratification.
