

- (v) Confirmation of service of Dr. B. Pohlong  
Lecturer, Department of Philosophy

Dr. B. Pohlong joined the Department of Philosophy, NEHU as Lecturer on 06.05.2005 and was placed under probation for a period of 2 years. He has completed the period of probation on 05.05.2007.

It may be mentioned herein that Dr. Pohlong, at the time of joining this University, had retained his lien against the substantive post of Lecturer at the Kiang Nangbah Government College, Jowai.

As per the Government of India Rule, where a Government servant is to be absorbed permanently by the foreign employer under his organization, it will be incumbent on the borrowing department to consult the parent employer before issuing order absorbing the Government servant permanently. The order of permanent absorption should be issued only after the resignation of the government servant has been accepted by the parent organization. The Under Secretary, to the Govt. of Meghalaya, Education Department has (vide Annexure-A) conveyed that the Govt. of Meghalaya have no objection, if the service of Dr. B. Pohlong is confirmed as Lecturer in the Department of Philosophy, NEHU and thereby terminating his lien with the Kiang Nangbah Govt. College Jowai.

The Self appraisal Report, which has been duly countersigned by the Head of Department in the verification data of Part-II of the form and as submitted by Dr. B. Pohlong, will be tabled by the Chair.

In view of the above, the matter is placed before the Council for consideration of confirmation of service of Dr. B. Pohlong, Lecturer in the University w.e.f. 06.05.2005.
