The Deputy Secretary, Govt. of India, Ministry of Human Resource Development, Department of Education vide letter dt. 11.9.98-Annexure-I has intimated of the proposal for extension of deputation in respect of Shri. Atul Dev Sarmah for the 6th year w.e.f. 25.8.98.
