

- (xv) Appointment of Dr.D.R.Syiemliem, Reader, Deptt. of History, NERU, Shillong as Dean Students' Welfare.

The term of appointment of Dr.D.R.Syiemliem, Reader, Deptt. of History, NERU, Shillong as Dean Students' Welfare was for a period of 3 (three) years w.e.f. 19.5.92 and expired on 18.5.96 and he was further extended for a period of 1 (one) year from 17.5.95 to 18.5.96.

In terms of the provision of Statute 8 of the NERU, Act, 1973 and subject to ratification by the Executive Council, the Vice-Chancellor, has re-appointed Dr.D.R.Syiemliem, Reader, Deptt. of History, NERU Shillong as Dean Students Welfare for a further period from 19.5.96 upto 31.3.97.

During the period from 1.4.96 to 2.7.96 Dr.Syiemliem was on Earned Leave and the Vice-Chancellor has ordered that Prof. J.C.Binwal, Head, Deptt. of Library & Information Sciences will look after the office of the DSW w.e.f. 1.4.96 to 30.6.96. However in between the said period Prof. Binwal has applied for a long leave w.e.f. 1.5.96 then Dr.N.Kumar, Reader, Deptt. of Sociology was asked to look after the office of the DSW effective from 1.6.96 till Dr. Syiemliem, DSW, resumes charge on 3.7.96 on expiry of his leave.

The matter is therefore placed before the Executive Council regarding payment of remuneration of Rs.600/- p.m. in respect of Prof. J.C.Binwal for looking after the office of the DSW w.e.f. 1.4.96 to 31.5.96 as well as to Dr.N.Kumar w.e.f. 1.6.96 to 2.7.96 during the absence of the regular DSW. The remuneration to Dr.D.Syiemliem the rate of Rs.600/- may be paid only with effect from 3.7.96 onwards.

The action taken by the Vice-Chancellor in appointing Dr.Syiemliem as DSW for a further period upto 31.3.97 is therefore placed before the Executive Council for ratification.
