
1. That your services will be governed by the Act, Statutes, Ordinances, Rules and Regulations of the University in force including C.C.S (Rules) from time to time.

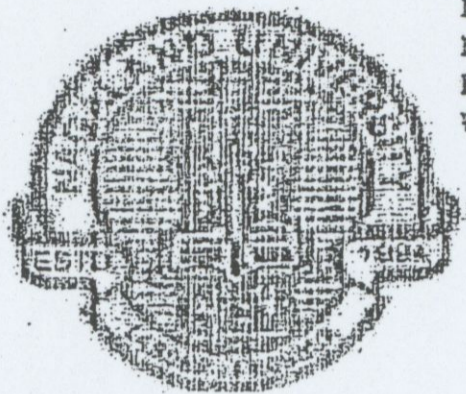

The additional financial compensation asked for in my letter of dated 23<sup>th</sup> March, 2007 was to off-set there deficiencies of Tura campus of NEHU.

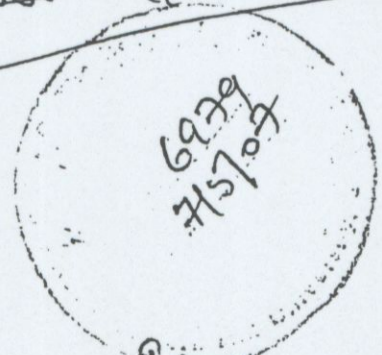
If said compensation are not agreeable to NEHU than matter may please be treated as closed.
