iv) Lien case of Dr. V.K.Kumar, Prof., Department of Commerce.

Dr. V.K.Kumar was granted lien for one year w.e.f. 22.8.1997 to join the IIM(K) Calicut approved by the E.C. at its 94th meeting held on 23.9.1997, vide No:EC:94:97:3:(vi) and then extended for another one year w.e.f. 22.8.1998, vide EC:99:98:3:(i) held on December 8.1998, and further extended for another period of one year w.e.f. 22.8.2000, approved vide EC:106:2000:6:3:(i) held on 13.4.2000, on the condition that he either reverts to NEHU OR resigns after the period of extension of lien beyond the 3rd year.

In this connection, Dr.V.K.Kumar vide his letter dt.9.8.2000 requested permission to revert to NEHU on Sept.28.2000, in view of his involment in the teaching course in the IV term. The Vice-chancellor, then approved the grant of permission allowing him to join NEHU on Sept 2000, vide office letter dt.28.8.2000, Dr. V.K.Kumar vide his letter dt Sept 30,2000, stated that in view of some academic matters to be settled he has been relieved only on Sept.28.2000 and as per the charge report forwarded by the Teacher Incharge, Commerce Deptt., Dr. V.K.Kumar assumed charge in the Deptt. on Sept 30.2000.

Since the 3rd year period of extended lien expired on 21.8.2000, and that Dr.Kumar could be released from IIM(K) Calicut only on 28.9.2000 and also in view of academic matters as stated by him, the gaps period from 22.8.2000 to 28.9.2000 may therefore be regularised by **granting** extension of lien as a special case beyond the 3rd year period.

The matter is placed before the Council for decision and consideration.
