

upon the formation of the Central University in Mizoram.

AC:59:98:5:8: (i): Para 5 of the Agenda Note was read as “ The recruitment criteria for PUC Teachers and the teachers for University P.G. Departments are the same so far as qualifications are concerned excepting for those who had been recruited before the taking over of P.U. College by NEHU but the composition of the selection Committee is not the same”.

The two Representatives of the Pachhunga University College Teachers' Association presented their views before the Council and answered questions placed before them.

The Council after consideration of the agenda note and also the verbal representation made by the representatives of PUCTA, RESOLVED that those teachers of Pachhunga University College who opt to continue in NEHU service, after the establishment of a new University in Mizoram, will be suitably accommodated within the existing academic programmes of the North - Eastern Hill University until such time as a permanent alternative is evolved for their consolidated placement, the University may apprise the Ministry of Human Resource Development and the University Grants Commission of the additional financial and infra-structural provisions that will have to be made to facilitate the above arrangement . The University, at the moment is not in a position to start a Constituent College of its own.



7. Children of employees with all India transfer liability, excluding private organisations.

8. Donor non-resident Indian.

Deleted.

Note:

1. In case(s) of equal claim(s) (between the intra or inter categories) a written test / oral test, as may be decided by the concerned Deptt., may be held to determine their inter-se merit.
2. Category under Sl.2,7 and 8 stand deleted, as the same are likely to create some administrative problems some day in the future.

3. Under this scheme, each Department will be required to prepare a consolidated list of all applicants under the quota and finalise the list of selected candidates based on the above principle.
4. Under the existing principles for such selection, the performance of such students at the qualifying examinations was not taken into account at all. However, under the proposed scheme, the same is proposed to be taken into account, in addition to the points of special consideration.
5. In the same logic that a candidate can apply for admission into more than one discipline, such candidates may also apply for other disciplines.
6. A candidate applying to be considered under this quota, shall be required to fill in only one application form for such, which will be considered under the open, reserved or University special quota. However, if such applicant is applying to more than one Deptt., shall be required to fill in separate application.
7. Other procedural methods to be followed shall remain the same.

**ORDINANCE OA-
ON CERTIFICATE AND DIPLOMA COURSES**

1. The University shall conduct Certificate Courses of one semester duration (six months) and Diploma Courses of two Semester duration (one year).
2. The Syllabus for the Courses shall be as prescribed by the Board of Post Graduate Studies / or Steering Committee and approved by the School Board and Academic Council.
3. The eligibility for admission to the Courses shall be as under :

A. CERTIFICATE COURSES

10 + 2 examination Higher Secondary / PU or equivalent.

B. DIPLOMA COURSES

B.A./B.Sc./B. Com. or equivalent examination of a University established by law.

4. There shall be an examination conducted by the University at the end of the Course on the date and place to be notified by the University.
5. The medium of instruction and examination shall be English.
6. The Course structure and distribution of marks shall be as under:

A. CERTIFICATE COURSES

There shall be 4 Papers of 100 marks which may be inclusive of Practicals which however should not exceed 25% of the total marks.

B. DIPLOMA COURSES

There shall be 8 Papers of 100 marks which may be inclusive of Practicals which however should not exceed 25% of the total marks.

7. The minimum pass marks in each of the Papers shall be 40%. The successful candidates shall be classified as under:-
 - (i) Second Division - those who obtain 45% or more, but less than 60% of the aggregate marks.

(ii) First Division - those who obtain 60% or more, but less than 75% of the aggregate.

(iii) A candidate who passes with 75 % or more marks in the aggregate shall be declared to have passed the Course with "Distinction".

Sub: AC Resolution on Item 5:8:7: (1) made in the 59th meeting of the Academic Council on 19.11.98.

Sir,

With due respect I would state that I disagree with the resolution on the item noted above.

In the Ordinance OC-4.1(1) it is clearly mentioned that for admission to the Ph.D. Programmes a candidate shall have at least 55% marks in his / her Master's Degree in the subject concerned / allied subject / cognate subject. Further, in OC-4.1(3) (v) a mention of persons having Master's Degree in the relevant and allied subject has been made for admission to the Ph.D. Programme.

Now, if there is no list of allied / relevant / cognate subjects for each Department and each department has a fully free will to consider the fitness of any candidate with whatever background and training he / she might be, then it will be, to my mind, a violation of the spirit (and perhaps of the letters) of the Ordinance.

The makers of the Ordinance must be having something at the back of their minds while using the words like "allied", "cognate", and "relevant". If these words mean "whatever a department thinks at any time 'relevant, allied or cognate'", it is too far-stretched interpretation of these words and perhaps, to my mind, not in conformity with the spirit in which these words have been used in the Ordinance.

I do respect the wisdom of every department in such matters, but, nevertheless, I feel its implications, if stretched far, may mean the words like allied / cognate / relevant are synonymous with "whatsoever". I fear unbridled freedom. Human beings are fallible. So they need rules, commandments, etc.

That is the reason why I have chosen to request you to kindly record my note of dissent to the resolution adopted unanimously (except me) by the Academic Council. This, of course, I have chosen to do with a heavy heart, though with due respect to the system of democratic decision - making and the wisdom of the Council.

But, then, by implication, I would not be wrong if I pray that OC-4.1(1) and OC-4.1(3) (v) should be amended such that the words like "subject concerned", "allied", "cognate" and "relevant" do not appear there lest they attract someone like me to seek their meanings anywhere except in the topical free will of any department to admit any person with whatsoever background for doing Ph.D. Research work on any research topic whatsoever. Of course, the limit of 55% may be retained on the marks obtained in the Master's Degree, though many questions can be raised on this also because in matters of doing research how can one strictly distinguish a candidate (ability wise) who has 54% marks from another candidate who has 55% marks ? But I would not raise this question.
