(i) Study leave of Dr. Shiva Kumar

Dr. Shiva Kumar Lecturer Department of Geology Joined the Pachhunga University College on 26/7/89. He was granted study leave for a period of two years w.e.f. 15/3/97 to 14/3/99 for his post doctoral research work at Banaras Hindu University and duly approved vide Executive Council resolution No. 96:6:3:(iii) held on 7/12/96. On his failure to resume his Department after the expiring of the study leave he was directed by the Office to Join duties immediately failing which the period will be treated as absence without leave and action will be initiated under clause 10 of F 19 of NEHU Ordinance O.E.6 accordingly Dr. Shiva Kumar joined his duty on 19/5/99 as he was released from Banaras Hindu University on 24/3/99 and stated to be under medical treatment from 14/3/99 to 15/3/99 as supported by the medical certificate.

In view of the above, the Vice-Chancellor, NEHU has approved the regularisation of the period of absence as follows:-

1. Extension of Study leave w.e.f. 15/3/99 to 24/3/99.
2. Commuted leave on Medical ground w.e.f. 25/3/99 to 16/5/99
