(i) Recommendations of the different Selection Committees for recruitment to different faculty positions of the University.

EC:112:2002:6:1:(i): The Chairman at the outset gave the background leading to the aborting of the Selections in Economics. The Chairman also explained that a few days before the beginning of the Selections for placement under the Career Advancement Scheme the University had received fresh Guidelines for promotion of Readers to Professors from the University Grants Commission instructing the University that the same should be given effect immediately. However, the
