Secondly, medical fitness, a requirement for confirmation has <sup>also</sup> been submitted by them from the authorised medical attendant and has not considered any disqualification for employment in permanent capacity in the post held by them.

Marbaniang, Deputy Registrar (Estt.I) for confirmation against one of the posts of Deputy Registrar created under the 8th Plan period and Smt. Lalremsiami, Assistant Librarian against the 6th Plan post sanctioned under U.G.C. letter No.F.7-20/81 (E-2) dt. 1.6.84 respectively from the date of joining. The same will be tabled by the Chair.

The matter is placed before the Executive Council for consideration of the above two officials' confirmation with effect from the date of joining.
