(vi) CONDONATION OF TIME-BARRED LTC CLAIM IN RESPECT OF PROF. R.N. PRASAD.

Prof. R.N.Prasad, Deptt. of Public Administration Mizoram Campus, Aizawl who had availed LTC without any advance for visiting his Home Town (Bajrahan) for the Block Year 1994-95, submitted the final bill after the stipulated period of 3(three) months time specified in the LTC rules. For that reason the claim could not be entertained. As per rule, "a claim for reimbursement of expenditure incurred on journey under LTC should be submitted within 3(three) months after the completion of the return journey, if no advance has been drawn. Failure to do so will entail forfeiture of the claim and no relaxation shall be permissible in this regard". The rule also says, "Save as otherwise provided in these rules, where any Ministry or Deptt. of the Govt. is satisfied that the operation of any of these rules causes on due hardships in any particular case that Ministry or Deptt. as the case may be, may by order for reasons to be recorded in writing, dispense with or relax the requirements of that rule to such an extent and subjected to such exceptions and conditions and it may be considered necessary for dealing with the case in a just and equitable manner provided that no such order shall be made except with the concurrence of the Deptt. of Personnel and Training".

Prof. Prasad has now represented to take up his case to the Executive Council for condonation with the reason for delay in submission of the claim being his ignorance about the LTC rules.

In view of the above, the matter is placed before the Executive Council for consideration and condonation of the time-barred claim.
