

- (xiii) Further extension of the term of appointment to Shri S.R. Sen, as University Legal Adviser (Headquarters), Shillong for a period of three years with effect from 28.7.99.

The three years contract term of appointment of Shri S.R. Sen as University Legal Adviser (Headquarters), Shillong expired on 27.7.99. Shri Sen was initially appointed as Legal Adviser of the University for 3 years with effect from 28.7.93 vide E.C. resolution No.EC:79:93:02(x) passed in the 79th meeting held on 20.7.93. The contract term of appointment for another three years with effect from 28.7.96 was also approved by the Executive Council vide its resolution No.EC:90:96:6:2(ix) passed at the 90th meeting held on 18.7.96. The terms and conditions of the contract appointment was the same as agreed to by Shri Sen right from the time of his initial appointment as Legal Adviser of the University in 1993 vide annexure-I.

On the basis of the same terms and conditions and with the approval of the Vice-Chancellor, an offer of contract appointment for a further period of 3 years w.e.f. 28.7.99 was again made to Shri S.R. Sen vide annexure-II. Accordingly, in his reply dated 11.10.99 vide annexure-III, Shri Sen has intimated that the existing terms and conditions are acceptable to him. However, since he has been designated as Senior Advocate w.e.f. 3rd June, 1999 by the Gauhati High Court vide notification No.HC.III-60/99/2353/A dated 3.6.99(Annexure-IV), the North-Eastern Hill University may consider enhancing his retainership fee from Rs.2000/-p.m. to Rs.2500/- p.m. with effect from 28.7.99. It may be mentioned that to Shri A.K. Phookan, Sr. Advocate and University Counsel at the Gauhati High Court(Principal Seat), Guwahati, the University has agreed to payment of retainership fee at Rs.3000/- p.m. vide EC resolution No. EC:94:97:6:2(x) passed at the 94th meeting held on 23.9.97.

As Shri S.R.Sen is looking after all the cases pertaining to NEHU even after 28.7.99, V.C. has provisionally agreed to extend the term of appointment for three months w.e.f. 28.7.99 to 27.10.99, subject to ratification by the Executive Council.

The matter of further extension of 3 years contract appointment to Shri S.R. Sen w.e.f. 28.7.99 is placed before the Council for consideration and approval.
