The Council in its resolution No.EC:98:6:3: (vi) held on 15.9.98, approved the grant of lien to Dr.B.S.Betola for a period of two years w.e.f.16.11.98 AN to join as Reader in J.N.U,Delhi and the lien expired on 16.11.2000.Dr.B.S.Betola had informed that he will be confirmed from the date of joining (Annexure-I) and desires to relinquish his position in NEHU, and requested to terminate his lien.However, the Asstt.Registrar (Acad),J.N.U, in his letter stated that a civil writ petition has been filed against JNU regarding appointment of Dr.B.S. Betola which is pending in the High Court of Delhi and that the confirmation will be considered only on disposal of the Civil Writ Petition and acceptance of resignation from NEHU, Annexure-II.

In view of the position ,Dr. Betola in his letter dated 21.5.2001, Annexure-III, requested for extension of his lien for another period of one year w.e.f. 16.11.2000.The Vice-Chancellor after due consideration of the fact approved the extension of lien for another period of one year and orders issued accordingly.
