

## SCHOOL OF SOCIAL SCIENCES

The School of Social Sciences came into existence with the establishment of the Departments of History, Political Sciences, Economics and Philosophy. Later the departments of Anthropology, Public Administration and Psychology were established and included in this School. After the reorganisation of the Schools by the University in 1994, this once largest school in the University was reduced in size in terms of the number of Academic Departments and Centres under its Jurisdiction. Presently the School has three departments - the Department of History, Political Science and Sociology, and the Centre of Literary and Cultural Studies, at the Headquarters at Shillong and the Department of Psychology and Public Administration at Aizawl, Mizoram.

The School admits more students every year in its MA Courses than any other School. It also has a large number of M Phil and PhD students.

The faculty of the School is known and recognised widely in the areas of its specialization and some of them have received national awards and other academic distinctions.

### Centre for Literary and Cultural Studies

Besides the usual programme of teaching and research the Centre has entered into a dialogue during the year with the Ford Foundation to initiate a Folklore programme including research project on ethnomusicology, festivals and rituals, folk art and craft and Women's folklore and setting up of an Audio-Visual Folklore Archive at the Centre. The Ford Foundation has decided to offer grants for the purpose.

**Department of History**

Established in 1974 this Department has been organised, as its placement in the School of Social Sciences would suggest, on the concept of history as a Social Science. Its character, distinguished by an emphasis on the study of peoples and regions with particular reference to social and cultural

development is with special reference to India and within it, North-East India. The department's academic objectives are (1) to provide on the Master's level a broad knowledge of human history and particularly of the areas and themes of special concern to the Department and the modern approaches to its study through a suitably structured and balanced syllabus; and (2) to promote historical research in hitherto unexplored areas, especially in the North-eastern region through the MPhil/PhD programmes and faculty members' research.

### Seminar/Conference etc. :

The department organised a seminar on "Sources and their Interpretation for Study of the Societies of Meghalaya" on 31 October and 1st November, 1996, under the UGC sponsored Special Assistance Programme. The aim of the Seminar was to bring together select participants working on various aspects of the theme, research scholars, college and university teachers - so as to locate the sources, identify their relevance and limitations, and demonstrate the methods and approaches with which to reconstruct aspects of the societies of Meghalaya. In all, 14 papers were presented, dealing with topics ranging from pre-historic societies to modern ones. Admittedly, not all societies within Meghalaya would be covered; those that figured prominently in the discussions were the Khasis, Jaintias and the Garos.

Some participants re-examined conventional sources, i.e., written documents from new perspectives. Others explored hitherto nearly untapped sources - oral traditions, folkloristics, linguistics, archaeology, music and archival materials - to supplement, corroborate, enlighten and even demolish certain generally accepted observations made by earlier writers on the societies of Meghalaya.

The Department had two Visiting Professors in the year under review, Professor S.R.Singh who had come on a one year tenure till 30th June, 1996, taught Modern Indian History and contributed to the Department's research programme. In November, 1996 professor Robbins Burling, a Fulbright Fellow was attached to the Department. He has assisted various departments in their M.A. Programmes, delivered lectures within and outside the University and conducted research in the Garo Hills.

Syiemlieh spent another month at the M.S.H., Paris during January-February, 1997 under the India-France Cultural Exchange Programme.

Professor Imdad Hussain was elected Executive Member of the Indian History Congress in December, 1996.

**Department of Political Science**

The Department was established in 1974 with 35 students and two teachers. By 1992-93 the Department had on its rolls 80 students with a sanctioned strength of 13 faculty members. The Department started a regular M.Phil programme from the academic year 1979-80 with six regular and four special M.Phil students. Apart from M.A. and M.Phil courses, the Department also provides research facilities leading to a Ph.D. degree. During 1996-97 six Ph.D. students belong to the Scheduled Tribe communities of the North-Eastern states took admission.

The Department aims at building an academic community of students, researchers and teachers devoted to a dispassionate, open and critical study of Political Science. Its teaching and research programmes seek to promote inter-disciplinary studies, to make courses and studies socially relevant, and to develop in the students and awareness of the basic needs and issues of the country and to equip them intellectually to fulfil these needs.
