

- (vi) Extension of lien period in respect of Dr V.B. Singh, Reader, Department of Horticulture, SASRD, Medziphema upto 4.7.99 -

Dr V.B. Singh, Reader, Deptt. of Horticulture, SASRD, Medziphema was granted lien for a period of two years to enable him to join the post of Professor at Nagaland University with effect from 5.7.96.

The Dy. Registrar(Estt), Nagaland University vide letter No.NU/SASRD/G-12/98-1987 dated 17.10.98 (Annexure 'A') requested for extension of lien period of Dr V.B. Singh for the third year. In term of GOI, M.H.A. OM No.60/37/63-Ests(A) dated 14.7.1967 of para (2) of F.R - 13 a permanent servant can retain his lien for a period of 2 years and should either revert to the parent department within the said period or resign from the parent department at the end of the period.

However, under para (5) of the said Government of India order, the Government servant may be permitted to retain his lien for another year with the given undertaking in exceptional cases where it is understood that confirmation of the Govt. servant in the department is due to the administrative reason.

In view of the above provision and that of the request of the Dy. Registrar(NC), the Vice-Chancellor has approved the extension with effect from 5.7.98 to 4.7.99 with a condition that Dr V.B. Singh will either revert to his parent department or resign from the parent department on completion of the extended period.

The matter is placed before the Council for ratification.
