(i) Re-employment of Prof. K.P.Nath.

The Executive Council in its resolution No. EC:108:2000:6:2:(iv) held on 8.12.2000 RESOLVED to regret the re-employment in respect of Prof.K.P.Nath as the recommendation by the Deptt. Committee(Deptt. of Education-MC) was not received.

The Pro-Vice-Chancellor, Mizoram Campus in his fax message dated 15.12.2000, stated that as there was no provision for recommendation of the Deptt. in the cases of re-employment in the old rules RU-2 and that the application was forwarded without the comments of the Deptt. Committee. He however informed that the faculty meeting was held on a later date(on Dec.14,2000) and also forwarded the minutes thereof(The minutes of the meeting placed at ANNEXURE-I)

The matter was then put up for re-consideration, and the Vice-Chancellor approved that in the meantime Prof. Nath be allowed to continue on re-employment terms after his retirement on superannuation on 31.12.2000 till further decision is taken by the Executive Council, Prof.Nath has been informed accordingly. Date of birth of Prof.K.P. Nath being 1.1.39, he retired on superannuation on 31.12.00. He fulfills the eligibility criteria as laid down in the amended Rule RU-2.

The matter is placed before the Council for re-consideration of re-employment wef. 1.1.2001 for 3 years.
