

(vi) Termination of service in respect of Dr.R.Lalthangliana.

Dr.R.Lalthangliana Lecturer,Pachhunga University College was elected as MLA to the Mizoram Legislative Assembly since 1989 and was granted Extra ordinary leave from 1/4/89. Dr.R.Lalthangliana has already completed ten years as sitting MLA on 31/3/99 with permission granted to contest the 1989 and 1993 election. Having returned successfully, extra ordinary leave was granted with effect from 1/4/89 . But in view of the term of 10 years restriction imposed vide addendum to Regulation RE-6 of clause 3 (iii) he should have either resumed duties on 1/4/99 or the post is deemed to have been vacated. As Dr.Lalthangliana has failed to join the post held bym him with effect from 1/4/99 and in view of the addendum to Clause 3 (iii) and EC decesion No: EC:96:98:3:(xi) the post held by Dr.Lalthangliana is to be treated as vacant. The Principal PUC vide letter dt. 23.4.99 has informed that Dr.R.Lalthangliana has not joined the College till date though the office had already informed him vide letter F.15-56/Estt-II/86-604 at anexure I.

The matter is placed before the Executive Council for decision.
