Shri Thomas Job K, Scientific Officer, RSIC, had applied for the grant of Extra Ordinary Leave for the period of 1(one) year w.e.f. 7.8.2000 to enable him to take up an assignment as Technical Laboratory and Instructor in the American University of Sharjah.

Shri Job had earlier been granted E.O.L. for 3 years w.e.f. 1.1.95 under Rule 32(3)(a) of CCS Leave Rules-(Annexure-I) and in terms of the Bond executed by him at that time he had to serve for a minimum period of 3 years after expiry of E.O.L. but he could not complete the above period which is short by 8 months and 14 days.

Accordingly, after having considered that RSIC staff are treated at par with NEHU staff and that vide 90th Executive Council No. 90:96:6:6:(xix) had approved the grant of advance increment for Ph.D/M.Phil to the Scientific Officer/Sr.Scientific Officer and also that one teacher Dr.E. Laitflang, Reader in Political Science was permitted by the 103 Executive Council vide Resolution No. 103:99:6:3(vi) to proceed on EOL to take up an assignment a private employment as Director, M/s Etnily, Beuty Tribe, London, the Vice Chancellor approved the grant of EOL to Shri Thomas Job, Scientific Officer for a period of 1(one) year w.e.f. 7.8.2000 to 6.8.2001 to take up the assignment in the American University at Sharjah on the similar line as approved in the case of Dr. E. Laitflang but under rules 32(3)(a) of CCS leave rules and on his assurance to refund the entire amount of Rs.20,000(Annexure-II).

The matter is place before the E.C. for ratification.
