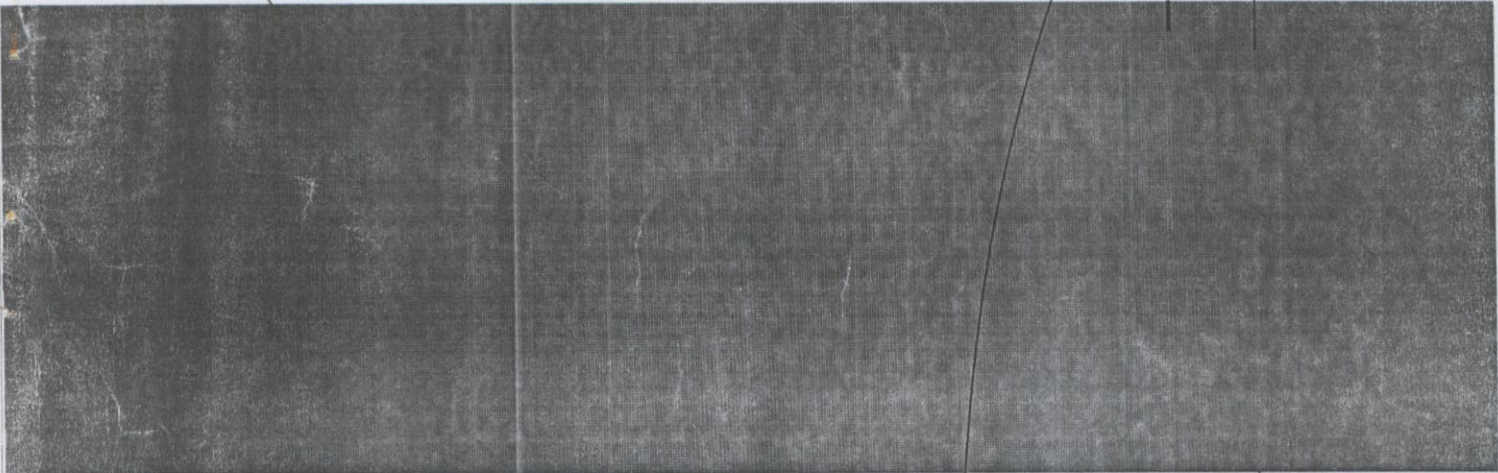
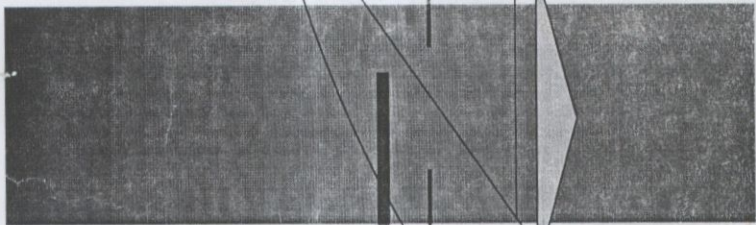

5:1- Statutes, Ordinances, Regulations & Rules

AC:66:2001:5:1:(i): The Council considered the Ordinance on the Rajendra Kumar Sunchari Devi Jain Charitable Endowment and RESOLVED to approve the Ordinance as per Annexure -A.

However, the rules are to be strictly adhered to and rather than the teacher applying for extension the office may ask the teacher if she/he is interested in re-employment at least one year before the date of her / his retirement. Further, the Department is to specify the reasons for or against extension of service. A Committee


may be appointed to look into the question of students' assessment for all teachers and the matter may be placed in the next meeting of the Council for discussion.


