

- (xi) Technical resignation tendered by Prof. M.P.Mahajan, Deptt.of Chemistry.

Prof.M.P.Mahajan, proceeded on two years lien w.e.f 14.4.96(AN) to take up an assignment as Professor in Pharmaceutical Sciences, Guru Nanak Dev University, Amritsar, approved by the Executive Council at its 89th meeting held on 8.3.96 vide resolution NO:EC:89:96:6:3:(iii).

On February 1998, vide his letter dated 19.2.98, he had informed that he is being permanently absorbed at Guru Nanak Dev University w.e.f 14.4.96, date of his joining and has requested to terminate his lien w.e.f 14.4.98(AN). The Dy.Registrar (Esstt) Guru Nanak Dev University send a letter dated 18.2.98 addressed to the Registrar, NEHU, stating that the University will not be paying any leave salary & pension contribution in respect of Dr.M.P.Mahajan who joined G.N.Dev University on 15.4.96 FN, for the period from 15.4.96 to 14.4.98. He would be deemed to have been absorbed w.e.f 15.4.96 on vacation of his lien from NEHU.

In this connection Prof.M.P.Mahajan, has been advised to submit a technical resignation, vide FAX Message dated 23.4.98. He then submitted his technical resignation vide FAX dated 24.4.98. On receipt of clearance certificates from all the concerned sections of NEHU, that Prof.M.P.Mahajan has no dues outstanding against him, the Vice-Chancellor accepted the technical resignation tendered by Prof. M.P.Mahajan w.e.f 14.4.96AN and formal orders was issued to him dated 21.5.98. His lien at NEHU stands terminated w.e.f 13.4.98.

The matter is reported to the Council for ratification.
