

**(x) Acceptance of Technical Resignation of Dr. Ashutosh Dash, Lecturer in the Department of Commerce.**

Dr. Ashutosh Dash had joined this University as Lecturer in the Department of Commerce on 28.05.2002 and was duly confirmed against the said post on completion of required probation period. Subsequently, after fulfilling the required conditions Dr. Dash was placed in the Senior Scale w.e.f. 29.05.2006 under Career Advancement Scheme.

On 02.08.2007, Dr. Dash had applied for the post of Assistant Professor at the National Institute of Financial Management, Faridabad, which was duly forwarded by the University. On having selected as Assistant Professor at NIFM, Faridabad, Dr. Dash was granted lien for a period of one year w.e.f. 11.09.2007(AN) so as to enable him to take up the said assignment. During the tenure of his service at NIFM, Faridabad, Dr. Dash had applied for the post of Assistant Professor at Rajiv Gandhi Indian Institute of Management, Shillong, through this University.

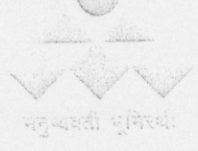
On having appointed as Assistant Professor at RGIIM, Shillong, Dr. Dash vide his letter dated 29.05.2008 (Annexure – 'A') requested the University to consider a fresh lien for a period of one year so as to cover his probation period at RGIIM, Shillong. In response, Dr. Dash was informed that he is required to revert back to NEHU and resume his duty first so as to enable the University to consider grant of fresh lien for a period of one year (Annexure – 'B'). Dr. Dash vide his letter dated 18.07.2008 (Annexure – 'C') has informed that due to compelling circumstances he has joined RGIIM, Shillong on the 03.07.2008 after getting released on 02.07.2008 from NIFM, Faridabad. In view of his joining RGIIM, Shillong on 03.07.2008, the initial lien which was granted to him to take up the assignment at NIFM, Faridabad was terminated by the University and accordingly Dr. Dash was asked to submit his technical resignation from the post held by him in NEHU w.e.f. 02.07.2008 (AN) (Annexure – 'D'). In response, Dr. Dash vide his letter dated 15.10.2008 (Annexure – 'E') tendered his technical resignation from the post of Lecturer in the Department of Commerce, NEHU w.e.f. 02.07.2008 (AN).

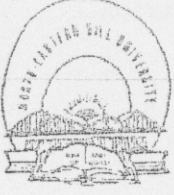



Proposed amendment

4.(1)The Registrar shall be appointed by the Executive Council on the recommendation of the Selection Committee constituted for the purpose or on deputation from an organized Civil Service. The appointment of the Registrar shall be for a period of five years and in the case of deputation, on usual Govt. of India's deputation terms. She/he shall be a whole-time salaried Officer of the University.
