

- (iv) Payment of remuneration to Dr. Y.S.Jain for looking after the Department of U.S.E.C.

Prof. Y.S. Jain, Reader, Physics Department following his appointment as Incharge Head, USIC w.e.f. 12.11.99 has requested for 10% of basic pay and conveyance allowance to discharge his additional duties (ANNEXURE-I).

In terms of Cl.5(2) of Ordinance O.E.-5, a teacher assigned with teaching or research work in the Department within the School or outside the School is not entitled to any extra remuneration. But the additional duties do not pertain to either teaching or research work.

The 98th E.C. Resolution 98:58:6:6:(xi) had approved the payment of Rs. 500/- p.m. to the then Prof. in-charge and Head USIC as remuneration for the additional job.

The Vice-Chancellor under consideration to the above, approved payment of Rs. 500/- p.m. on the similar line to Prof. Y.S. Jain for the additional charge likewise sanctioned to Prof. A.L. Verma.

The matter is placed to the council for ratification.
