

- (iv) Transfer of Miss.N.Ganguly from the Centre of Literary & Cultural Studies to the Deptt. of English, Shillong.

The Executive Council at its 62nd meeting held on 7.9.1988 vide resolution No.EC:62:88:08:(i) and 65th meeting held on 1.2.89, approved the transfer of Miss. N.Ganguly, Lecturer in English, from NEHU Nagaland Campus alongwith her post and she was temporary posted in the Centre of Literary & Cultural Studies, Shillong.

Miss. Ganguly made a request to the Vice-chancellor, vide her letter dated 1.5.96 stating that she was originally appointed by NEHU as a Lecturer in English, NEHU, Nagaland Campus, and that she accepted the transfer from Nagaland Campus and posted to the Centre, under unavoidable circumstances. That at present she is doing her post-graduation in English Literature and is in the final stages of submission of her Ph.D., in English Literature, she request the Vice-chancellor for consideration of her posting in the Department of English, Shillong.

The matter has been carefully examined, and comments of the Head of Department of English and Head of Deptt, CLCS for her transfer has been sought for. The Head of Deptt., English, vide letter dated 8.8.96, welcomed the transfer of Miss Ganguly alongwith her post and the Head of Deptt CLCS, vide his letter dated 26.9.96, has no objection to the transfer. In view of Head of Deptt. of English letter who had welcomed Miss. Ganguly to the Deptt. alongwith the post and the no objection from the Head of CLCS the matter was consider by the Vice-chancellor, and Miss. Ganguly was transfer to the Deptt. alongwith the post a order vide No.F.19-96/Estt.II/79-2963 dated 7.10.96.
